We are pleased to announce the Request for Applications for the annual approval of providers of supplemental educational services pursuant to the No Child Left Behind (NCLB) Act. Supplemental educational services are defined as tutoring and other supplemental academic enrichment services that are in addition to instruction provided during the school day. These services must be of high quality, research based, and specifically designed to increase the achievement of eligible students in attaining proficiency in meeting Florida's Sunshine State Standards. Students from low-income families who attend Title I schools that have been identified in their second year of in need of improvement, corrective action, or restructuring for the 2006-2007 school year are eligible to receive supplemental educational services.
