SUBJECT: 2006-2011 Local Educational Agency Plan – **Due Date June 30, 2006**

The Elementary and Secondary Education Act of 1965, as reauthorized by the “No Child Left Behind (NCLB) Act of 2001,” requires that a local educational agency (LEA) must have on file at the State educational agency (SEA) a State-Approved Local Educational Agency Plan.

The purpose of this memorandum is to provide you with the information that you need to write your district’s LEA Title I, Part A Plan. This plan must be completed every five years for the LEA to receive funds under Title I, Part A, Education of Disadvantaged Children and Youth.
