SUBJECT: New High School Transcript Data Elements 2011-2012

As part of the implementation of recent legislation related to student assessment and general requirements for high school graduation cited below, the Florida Department of Education (FDOE) has created new data elements for the FDOE 2011-2012 Information System Database Requirements. The new data elements include the following:

- Course Assessment Status (number 197232)
 - o Requirements specified in section 1008.22(3)(c)2.a.(I)-(II), Florida Statutes (F.S.)
- Online Course (number 197235)
 - o Requirements specified in s. 1003.428(2)(c), F.S.

In order to lend assistance with high school transcript recording, this memorandum provides frequently asked questions and answers that address these new data elements.

Frequently Asked Questions

Course Assessment Status

1. What is the definition of the new Course Assessment Status data element (197232)?

It is defined as the status of the student in relation to the assessment for a course in which an end-of-course (EOC) assessment is required in order for high school credit to be awarded.

2. What are the Course Assessment Status codes and corresponding definitions?

Code	Definition/Example
A	The student took and passed the EOC assessment required for the course as per section 1008.22(3)(c) 2.a., Florida Statutes (F.S.).
В	The student took and failed the EOC assessment required for the course as per s. 1008.22(3)(c) 2.a., F.S.
С	The student did not yet take the EOC assessment required for the course as specified in s. 1008.22(3)(c) 2.a., F.S.
D	The transfer student is exempt from taking the EOC assessment required for the course as specified in s. 1008.22(9)(b), F.S.
Е	The student took and passed the EOC assessment required for the course as per s. 1008.22(3) 2.a., F.S., and consequently exempted all or part of the course as per s. 1003.4295(3), F.S.
F	The student with a disability had the EOC assessment requirement for this course waived as per s. 1003.428(8)(b) 2, F.S.
Z	The course does not have a required EOC assessment or the student is not in a cohort that requires taking the EOC assessment for earning course credit for the course.

3. Where will the Course Assessment Status code be recorded on the Florida Automated System for Transferring Educational Records (FASTER) high school printed transcript?

The code will be recorded under the new Course Assessment Status (AC) column next to the Course Grade (GR) column. Please refer to the Sample High School Transcript within this document.

4. How is credit attempted and credit earned reported on the FASTER high school printed transcript?

Please refer to the Course Assessment Status Transcript Reporting Chart within this document for specific recording guidelines.

Course Assessment Status Code "A"

- 5. If a student is enrolled for two semesters and passed the EOC assessment required for the course at the end of the second semester, what is recorded on the transcript? (Refer to Example 5 in the Chart)
 - For districts using annual reporting (Term 3):
 - o An "A" code is recorded in the AC column.
 - The grade is recorded in the GR column.
 - o A "1.0" is recorded in the Credit Attempted column and a "1.0" is recorded in the Credit Earned column.
 - For districts reporting by semesters:
 - o A "C" code is recorded in the AC column after first semester.
 - o An "A" code is recorded in the AC column after second semester.
 - o The grade is recorded in the GR column for the first and second course entries.
 - o A "0.5" credit is recorded in the Credit Attempted column for the first and second course entries.
 - A "0" is recorded in the Credit Earned column for the first course entry and a "1.0" credit is recorded in the Credit Earned column for the second course entry.
- 6. If a student is enrolled for two semesters and passed the EOC assessment required for the course at the end of the first semester, what is recorded on the transcript? (Refer to Example 6 in the Chart)
 - An "A" code is recorded in the AC column for first and second semesters.
 - For districts reporting by semesters:
 - The grade is recorded in the GR column for the first and second semester course entries.
 - A "0.5" credit is recorded in the Credit Attempted column for the first and second course entries.
 - o A "1.0" credit is recorded in the Credit Earned column for the first semester.
 - o A "0" is recorded in the Credit Earned column for second semester.

Course Assessment Status Code "B"

- 7. If a student is enrolled for one semester in a course that requires EOC assessment passing scores in order for credit to be awarded and fails to earn passing scores, what is recorded on the transcript? (Refer to Example 2 in the Chart)
 - For districts using annual reporting (Term 3) and reporting by semester:
 - o A "B" code is recorded in the AC column.
 - o The grade is recorded in the GR column.
 - o A "0.5" is recorded in the Credit Attempted column and a "0" is recorded in the Credit Earned column.
- 8. If a student is enrolled for two semesters in a course that requires EOC assessment passing scores in order for credit to be awarded and fails to earn passing scores, what is recorded on the transcript? (Refer to Example 4 in the Chart)
 - A "B" code is recorded in the AC column.
 - For districts using annual reporting (Term 3):
 - o The grade is recorded in the GR column.
 - o A "1.0" is recorded in the Credit Attempted column.
 - o A "0" is recorded in the Credit Earned column.
 - For districts reporting by semesters:
 - o The grade is recorded in the GR column for the first and second course entries.
 - o A "0.5" credit is recorded in the Credit Attempted column and a "0" credit is recorded in the Credit Earned column for the first and second course entries.

Course Assessment Status Code "C"

- 9. If a student is enrolled for one semester in a course that requires EOC assessment passing scores in order for credit to be awarded and did not take the EOC assessment, what is recorded on the transcript? (Refer to Example 2 in the Chart)
 - For districts using annual reporting (Term 3) and reporting by semesters:
 - o A "C" code is recorded in the AC column.
 - o The grade is recorded in the GR column.
 - o A "0.5" is recorded in the Credit Attempted column and a "0" is recorded in the credit earned column.
- 10. If a student is enrolled for two semesters in a course that requires EOC assessment passing scores in order for credit to be awarded and did not take the required EOC assessment, what is recorded on the transcript? (Refer to Example 4 in the Chart)
 - A "C" code is recorded in the AC column.
 - For districts using annual reporting (Term 3):
 - o The grade is recorded in the GR column.
 - o A "1.0" is recorded in the Credit Attempted column.
 - o A "0" is recorded in the Credited Earned column.
 - For districts reporting by semesters:
 - o The grade is recorded in the GR column for the first and second course entries.
 - o A "0.5" credit is recorded in the Credit Attempted column and a "0" credit is recorded in the Credit Earned column for the first and second course entries.

Course Assessment Status Code "D"

11. What Course Assessment Status code is recorded on the transcript for a student who transfers into a Florida public school and has earned credit in a course for which an EOC assessment passing score is required to award course credit?

If the principal exempts the student from the EOC assessment, then a "D" code is recorded in the AC column. A school principal may determine in accordance with Rule 6A-1.09941, Florida Administrative Code (F.A.C.), State Uniform Transfer of High School Credits, whether a transfer student must take an EOC assessment in a course for which the student has credit that was earned from the previous school. Rule 6A-1.09941, F.A.C, is under revision.

Course Assessment Status Code "E"

- 12. If a student took and passed an EOC assessment required for a course through the Credit Acceleration Program (as specified in s. 1003.4295(3), F.S.) the student would be exempted from all or part of the course. What is recorded on the transcript? (Refer to Example 1 in the Chart)
 - An "E" code is recorded in the AC column.
 - An "NG" is recorded in the GR column.
 - A "0" is recorded in the Credit Attempted column.
 - A "1.0" is recorded in the Credit Earned column for annual reporting (Term 3) or a "0.5" is recorded in the Credit Earned column for the first and second course entries.
- 13. If a student took and passed an EOC assessment and was enrolled for one semester without completing the course, what is recorded on the transcript? (Refer to Example 3 in the Chart)
 - An "E" code is recorded in the AC column.
 - The grade is recorded for semester one in the GR column.
 - For districts using annual reporting (Term 3):
 - o A "0.5" credit is recorded in the Credit Attempted column.
 - o A "1.0" credit is recorded in the Credit Earned column.
 - For districts reporting by semesters:
 - o A "0.5" credit is recorded in the Credit Attempted column.
 - o A "1.0" credit is recorded the Credit Earned column for the first course entry.
- 14. What course number is recorded on the transcript for a student who took and passed an EOC assessment required for a course through the Credit Acceleration Program (as specified in s. 1003.4295(3), F.S.)?
 - Algebra 1 1200310
 - Geometry 1206310
 - Biology 1 2000310

Course Assessment Status Code "F"

- 15. If a student with a disability who has an individual education plan (IEP) is enrolled for two semesters and after attempting the EOC at least one time had the EOC assessment requirement for a course waived as per s. 1003.428(8)(b) 2, F.S., what is recorded on the transcript? (Refer to Example 7 in the Chart)
 - For districts using annual reporting (Term 3):
 - o An "F" code is recorded in the AC column.
 - o The grade is recorded in the GR column.
 - o A "1.0" is recorded in the Credit Attempted column and a "1.0" is recorded in the Credit Earned column.
 - For districts reporting by semesters:
 - o A "C" code is recorded in the AC column after first semester.
 - o An "F" code is recorded in the AC column after second semester.
 - o The grade is recorded in the GR column for the first and second course entries.
 - o A "0.5" credit is recorded in the Credit Attempted column and a "0.5" credit is recorded the Credit Earned column for the first and second course entries.
 - o A "0" is recorded in the Credit Earned column for the first course entry.
 - o A "1.0" credit is recorded in the Credit Earned column for the second course entry.

Course Assessment Status Code "Z"

16. What Course Assessment Status code is recorded on the transcript for courses that do not require an EOC assessment?

A "Z" code is recorded in the AC column. This code is also used if the student is not in a cohort that requires taking the EOC assessment for earning course credit.

Mathematics and Science Equivalent Courses

17. Which mathematics and science courses are required to have the new Course Assessment Status codes recorded on the transcript?

Recording Course Assessment Status codes next to a particular mathematics or science course is dependent on the school year and grade level of the student.

Algebra 1 EOC Assessment 2011-2012

A middle grades student completing Algebra 1 or an equivalent course must take the Algebra 1 EOC assessment and achieve a passing score to be awarded high school credit in 2011-2012 and thereafter.

A student who enters ninth grade in the 2011-2012 school year and thereafter must take the Algebra 1 EOC assessment and achieve a passing score to be awarded high school credit in order to satisfy graduation requirements.

Geometry EOC Assessment 2012-2013

A middle grades student who is completing Geometry or an equivalent course must take the Geometry EOC assessment and achieve a passing score to be awarded high school credit in the 2012-2013 school year and thereafter.

A student who enters ninth grade in the 2012-2013 school year and thereafter must take the Geometry EOC assessment and achieve a passing score to be awarded high school credit in order to satisfy graduation requirements.

Biology 1 EOC Assessment 2012-2013

A middle grades student completing Biology 1 or an equivalent course must take the Biology 1 EOC Assessment and achieve a passing score to be awarded high school credit in the 2012-2013 school year and thereafter.

A student who enters ninth grade in the 2012-2013 school year and thereafter must take the Biology 1 EOC assessment and achieve a passing score to be awarded high school credit in order to satisfy graduation requirements.

Next Generation Sunshine State Standards

The **Algebra 1 EOC** assessment is based on the Next Generation Sunshine State Standards course description for Algebra 1 and its equivalent courses, and must be administered to students completing the following courses:

- Algebra 1 1200310
- Algebra 1 Honors 1200320
- Algebra 1B 1200380
- Pre-Advanced International Certificate of Education (pre-AICE) Mathematics 1 1209810
- IB Middle Years Program Algebra 1 Honors 1200390

The **Biology 1 EOC** assessment is based on the Next Generation Sunshine State Standards course description for Biology 1 and its equivalent courses, and must be administered to students completing the following courses:

- Biology 1 2000310
- Biology 1 Honors 2000320
- Pre-AICE Biology 2000322
- Biology Technology 2000430
- Biology 1 PreIB 2000800
- IB Middle Years Program Biology Honors 2000850
- Integrated Science 3 2002440
- Integrated Science 3 Honors 2002450

The **Geometry EOC** assessment is based on the Next Generation Sunshine State Standards course description for Geometry and its equivalent courses, and must be administered to students completing the following courses:

- Geometry 1206310
- Geometry Honors 1206320
- IB Middle Years Program Geometry Honors 1206810
- Pre-AICE Mathematics 2 1209820

Special Note: The intent of the legislation was that all students complete these assessments, including those in accelerated courses being used to satisfy a graduation requirement, such as Advanced Placement (AP), International Baccalaureate (IB) and Advanced International Certificate of Education (AICE). These courses may or may not be on the list of "equivalent courses" for a particular subject. Therefore, if an accelerated course is being used to meet a student's high school graduation requirement for courses that require a statewide EOC, that student must complete the subject area EOC. In these instances, a Course Assessment Status code of "E" should be recorded in the AC column on the transcript for Algebra 1, Geometry or Biology 1, as appropriate, and a credit should be applied to the course reported with "E."

Online Course

18. What is the definition of the new Online Course data element (197235)?

- It is defined as an indicator of whether the student took this course under conditions that met the definition of an online course as per s. 1002.321(3), F.S., and s. 1003.428(2), F.S. An online course is one that is delivered using distance learning technology in an interactive learning environment.
- An online course has these key characteristics:
 - The curriculum is accessed and a majority of the instruction is delivered online.
 - o Teacher-student interaction

19. What are the Online Course codes and corresponding definitions?

Code	Definition/Example
N	This course was not taken under conditions that met the requirements to be an online course as per s. 1002.321(3), F.S., and s. 1003.428(2), F.S.
Y	This course was taken under conditions that met the requirements to be an online course as per s. 1002.321(3), F.S., and s. 1003.428(2), F.S.

20. Where will the Online Course code be recorded on the FASTER high school printed transcript?

The code will be recorded under the new ON column next to the AC column. Please refer to the Sample High School Transcript within this document.
