**REQUEST FOR PROPOSAL 2003-2004** 

We are pleased to inform you that the 2004 Florida Legislature appropriated \$4,000,000 for Alternative Schools/Public Private Partnerships for 2004-2005. Your district may apply for funding for one of these educational projects to serve at least 500 disruptive and low performing students per school in grades 6-12. Programs that are funded must provide proof of educational progress in reading and mathematics demonstrated in existing programs, of at least three years of experience, with similar student populations. All approved projects will have 18 months to expend the funds, with a beginning date of November 30, 2004.
